## Project Coordinator, Philadelphia School Nutrition Program

The Food Trust is seeking energetic and committed individuals for full-time positions to implement our school-based nutrition education program. This is a unique opportunity to positively impact children's health by providing nutrition education and increased access to nutritious and affordable food in lower income communities. The Program Coordinator serves as a nutrition educator in approximately 4 public schools throughout Philadelphia. Coordinators provide nutrition education to schools on a weekly basis on topics such as fruits & vegetables, whole grains and promoting healthy lifestyles. Coordinators also provide support to a team of 3 program associates. This is a unique opportunity to positively impact children's health by providing nutrition education and increased access to nutritious and affordable food in lower income communities.

### Responsibilities include:

- Establish and foster relationships with teachers, nurses, principals and school staff
- Provide nutrition education to students and caregivers to improve the overall health of the school community in the form of classroom lessons, school markets, school-wide events, and caregiver workshops
- Train teachers to successfully integrate nutrition education into their classrooms
- Collect documentation from teachers on an ongoing basis for program funding purposes
- Deliver educational materials to schools

### Additional responsibilities include:

- Support associates in implementing programming in their schools through assisting with classroom lessons, school-wide activities, fruit markets, professional developments, teacher meetings, documentation collection and delivery of materials
- Assist in training new staff
- Meet with managers on a weekly basis to assess region's progress
- Work with other coordinators and managers over the summer to develop programming for the school year

**Qualifications:** Bachelors Degree with course work in dietetics and/or nutrition. Leadership experience. Ability to handle multiple priorities, organize time effectively, and work independently and as a team player. Strong oral, written and communication skills; bilingual is a plus. Interest in urban education and a desire to work with school-age children, school staff, and caregivers. Program Associate positions involve regular travel throughout the Philadelphia region and require a valid driver's license and access to a reliable vehicle. The ideal candidate will have the following characteristics: a style that promotes collaboration and communication; a high energy level; public speaking skills; a sense of humor; an open mind; a commitment to The Food Trust's mission.
